

## JOLLY FUN DAY CAMP POLICY SHEET-ALL LOCATIONS

The **Registration Fee is Non-Refundable**. The First Week Tuition and the Last Week Security Deposit **may be refunded with a proper two (2) week written notice on file**.

**CAMP SITE EXTENDED HOURS:** Please note camp site extended hours per listing. **CAMP HOURS ARE 9:00 AM TO 3:30 PM.**  
**Norridge Location:** 6:30 am to 6:00 pm  
**Prospect Heights Location:** 6:30 am to 6:00 pm

**DES PLAINES DROP-OFF AND PICKUP ONLY:** Parents must enter gate #1 (by the pool) which is on Algonquin Road for drop-off and pick-up. All parents will receive a map in their orientation package for the proper route with-in the campgrounds for drop-off and pick-up.

Please have your child(ren) at their camp site no later than **8:30 a.m.** to ensure they make bus loading for the daily camp activities. For security reasons, please personally escort your child(ren) into the building, sign-in and notify a counselor of their arrival. Buses are scheduled to leave promptly at 9:00 a.m. In the evening, sign-out your child(ren) and check the group folder for parent information.

**CAMPER ATTENDANCE:** We recommend that the first two scheduled weeks in camp be consecutive to allow your camper(s) the opportunity to adjust and make friends in camp.

**PROGRAM CHANGES:** Please see the office for the "**CHANGE OF INFORMATION FORM**", which must be filled out and signed by the parent and the director in order to make changes of any kind. **A FULL TWO WEEKS NOTICE MUST BE GIVEN IN WRITING to delete weeks.** Weeks may be added on a space available basis.

**DRESS CODE:** Each camper is required to be dressed in a camp t-shirt, shorts, socks, rubber soled shoes and additional cover clothing suited to the weather and the activity scheduled for that day. **CAMP T-SHIRTS ARE REQUIRED TO BE WORN DAILY.** Additional regular or tank top t-shirts may be purchased at a cost of \$10.00 each. **CAMP TOWELS** are available at a cost of \$15.00 each. Please label **all clothes** and towels with your child's name using a permanent marker. **ALL ITEMS MUST BE LABELED.** Jolly Fun Day Camp is not responsible for lost items.

**SWIMMING:** We swim three mornings per week, beginning week 2 thru week 11 (weather permitting). On swim days campers should bring a swim suit, sun screen, and towel. Please bring swim gear regardless of what the weather looks like in the morning, as it may be possible to swim later in the day. I give my child(ren) permission to participate in any and/all water activities.

**ROLLER SKATING:** Our summer program will include several roller skating sessions. On roller skating days, which will be indicated on the camp schedule, please have your camper wear heavy socks. **NOTE:** Due to state regulations, all campers must wear socks to be permitted on the roller rink floor.

**CAMPER SPENDING MONEY:** The camp will designate specific field trip days when a small amount of spending money may be used. These days appear with a (\$) sign on the summer camp schedule. The recommended amount of spending money is **\$4.00 - \$5.00**. Please note, we cannot be held responsible for lost money. Parents of younger campers (**Apaches, Bunnies, Buccaneers & Leprechauns**), should put their money in an envelope with their name on it and hand it directly to the camp office.

**PAYMENT:** Tuition may be paid by cash, check, money order, certified check, Visa or Mastercard. The security deposit is applied to the last scheduled week in camp. Tuition is due preceding each week your child(ren) are to attend. For **Des Plaines** tuition received after close of day on Thursday is delinquent and will be charged an additional \$20.00 (Twenty Dollars) weekly until the delinquent tuition is brought current. For **Norridge/Prospect Heights** tuition received after close of day on Friday is delinquent and will be charged an additional \$20.00 (Twenty Dollars) weekly until the delinquent tuition is brought current. **Any week that is marked for attendance will be charged even if the child does not attend.**

Non-Sufficient funded checks will be charged \$25.00 (Twenty-Five Dollars) and future payments must be paid by a money order or certified check. If the outstanding balance is not paid within 30 days, your account will be processed for outside collection. Should this be necessary, an additional minimum charge of \$100.00 (One Hundred Dollars) or 50.0% of the outstanding balance whichever is greater is charged as a collection fee. Should it be necessary to initiate litigation, there will be a charge for attorney fees and court costs.

At discontinuation, if the account is carrying a credit balance, refunds will be mailed within six weeks.

**LATE ARRIVAL FEES:** Parents who arrive after closing time will be charged a late fee of \$15.00 for each 15 minutes, or portion thereof, that you are late. This money is used to reimburse the counselors for the inconvenience of staying after closing. The money should be paid in cash directly to them.

**PRE-PAYMENT BENEFIT:** Families who prepay the entire summer (minimum 10 weeks) receive a 2% discount on tuition and a free camp beach towel.

**COMMUNICATIONS:** Parents will receive a weekly copy of our camp newsletter "**THE FUN TIMES**", which will inform both campers and parents of the planned activities for the coming week. We have an open door policy and encourage parents to call or come into the office at any time if they have questions or concerns.
